ASSOCIATE MEMBERSHIP

An Associate Member is any individual who is the owner of or is employed by a firm engaged in an allied trade, industry or profession related to building.

REQUIREMENTS:

- \Box Two active member sponsors or two client references
- \Box Two credit/customer references

DEVELOPER MEMBERSHIP

A Developer Member is any individual who is the owner of or is employed by a firm engaged solely in land development. Any firm that conducts any form of construction (residential or commercial) must apply as a Builder Member.

REQUIREMENTS:

- \Box Two credit reference
- \Box Two active member sponsors
- \Box Certificate of General Liability with minimum of \$300,000 coverage

AFFILIATE MEMBERSHIP

An Affiliate Member is any representative joining an existing HBA Member company. NOTE: If the Primary member of the company drops their membership, the Affiliate will take over the Primary Membership at the higher rate to remain active or drop their membership. Affiliate members do not need to complete items #3 or #4.
